The principal terms of the Convertible Loan Agreement entered into by the Company with International Finance Corporation on 5 January 2018 has already disclosed by the Company's announcement dated 5 January 2018. The terms and conditions of the convertible loan has been amended on 23 December 2022, details of which was disclosed in the announcement of the Company dated 30 December 2022.
